On October 4, 2010, complainant Toshiba Corporation and respondents Wistron Corporation, Wistron InfoComm (Texas) Corporation, and Wistron InfoComm Technology (America) Corporation (collectively “the Moving Parties”) filed a joint motion for termination of the investigation based on a settlement agreement. Included in the joint motion is a request to suspend the procedural schedule. The Moving Parties state that the Commission Investigative Staff (“Staff”) supports the suspension of the procedural schedule.

ORDER

There being no opposition, the Moving Parties’ joint request to suspend the procedural schedule is hereby GRANTED. I will rule on the joint motion for termination after receiving Staff’s response, as the Moving Parties state that Staff intends to file a response.


